TWCA BOARD OF DIRECTORS MEETING Friday, December 2, 2022, 10:00 am | Omni Austin Downtown MINUTES

1. Call to Order – President Walt Sears

Amy Stelter had an excused absence.

2. Discussion and possible action on minutes from October 6, 2022

There was recommendation for an amendment to add Amy Stelter in attendance to the October minutes. Glenn Lord moved and Ed Shackelford seconded the motion to adopt the amended minutes, and the motion passed unanimously.

3. Report on TWCA Risk Management Fund – Jace Houston, Chair, TWCA RMF

Jace reported that John Grant retired, and the Fund welcomed John Womack with CRMWD to the board of trustees. The financial audit was completed and clean. The Fund also selected a firm for a performance audit. The next board meeting and annual membership meeting will take place at Lost Pines in Bastrop in coordination with the TWCA Annual Convention.

4. Discussion and possible action on 2023 TWCA-TGWA Management Agreement – Stacey Steinbach

Stacey gave an update on the TGWA-TWCA contract. Last December, the TWCA board authorized an exploratory committee to look at the contract. Due to divergent missions and potential for conflicts of interest, continuing this contract no longer make sense. TWCA staff have been working to transition management over the past few months and relationships have continued to remain positive. TGWA has hired Bobby Bazan as its first-ever Executive Director. He has worked with drillers and members of TGWA as well as TWCA. The proposed contract reduces payment over the next eight months. Staff will be supporting Bobby until September 2023.

Gary Westbrook moved, and Steve Walthour seconded the motion to approve the amended management agreement with TGWA, and the motion passed unanimously.

5. Discussion and possible action on financial matters – Mike Booth and Stacey Steinbach

- (a) Current Financials net revenue is higher than expected in part because TWCA never hired anyone for the TGWA project manager job, so personnel expenses are significantly below budget. TWCA is expecting a surplus of \$80-90K this year, which will allow TWCA to start rebuilding reserves. TWCA has exceeded \$400K in member dues income for first time ever.
- (b) 2021 Financial Review passed without incident.
- (c) 2023 Member Dues and Conference Fees The EC met to discuss member dues and appointed a committee to look at both. The EC proposes a seven percent increase for member dues. Stacey also highlighted the proposed 2023 sponsorship packet and mentioned that Freese & Nichols is formalizing the Friday breakfast for all three conferences.
- (d) 2023 TWCA Annual Budget the budget has been drafted to account for rapidly increasing hotel expenses, though actual costs are uncertain. TWCA will be moving offices in two weeks, saving the Association \$30K in 2023. Mike added that we have also increased registration fees at conferences for

2023. This hasn't been done in many years and is necessary to account for rising hotel costs. He and Stacey also noted that hotels are now requiring deposits for all events since the pandemic, sometimes years in advance, which can affect cash flow.

Stacey also highlighted that we are expecting a net loss in 2024 due to TGWA's departure. Kathy Jones moved, and Dan Buhman seconded the motion to approve the financials, 2021 review, 2023 member dues and conference fees, and 2023 budget, and the motion passed unanimously.

6. Discussion and possible action on Nomination Committee recommendations for TWCA President-Elect and Treasurer – Walt Sears

Walt named the members of the nominating committee: Allen Sims, Ed Shackelford, Mike Turco, Liz Fazio Hale, Karen Bondy, Emily Rogers, David Collinsworth, Darrell Grubs, and Tito Nieto. He reported that the committee met on Wednesday to discuss nominations. Noting that there are so many qualified and well-deserving candidates that the only real question is deciding the order in which they are nominated. Ed Shackelford reported that the nominating committee recommended Wayne Owen for president-elect to start in June 2023 based on his 20-year record of involvement and active engagement at the association and moved accordingly. Emily Rogers seconded the motion to approve Wayne Owen as President-Elect starting in June 2023 and the motion passed unanimously.

Next, Walt gave an overview of the treasurer position, explaining that the treasurer is charged with overseeing the financial reports, but does not sign checks, etc. He reminded the board that TWCA adopted new bylaws at the fall conference that call for TWCA to nominate and elect a Treasurer at the December board meeting. Mike Booth has served as the chair of our Finance Committee since 2015 and done a great job shepherding us into a new era. Walt reported that Mike has agreed to serve as our first Treasurer in a transition capacity. Emily Rogers moved, and Glenn Lord seconded the motion to elect Mike as the treasurer. The motion passed unanimously.

7. Discussion and possible action on proposals from TWCA Surface Water Committee – Lyn Clancy and Walt Sears, Co-Chairs

Lyn gave the report. The SW committee is tackling two items: one item is legislation related to WAM funding and prioritization. This initiative passed the surface water committee. The other item is direct onsite reuse TCEQ rule petition, Emily Rogers and Vanessa Puig-Williams have been coordinating through a subcommittee of the SW Committee. The full committee has approved the proposal, but it's possible that some organizations may push legislation encouraging TCEQ to act. Lyn recommended that the board approve the rulemaking effort and generally support any legislative action consistent with committee recommendations, but not initiate a bill.

John Hoffman moved and Larry Patterson seconded a motion to approve the SW committee's recommendation approving the draft WAM legislation and the Direct Onsite Reuse rulemaking petition as well as to generally support any legislation consistent with the petition, and the motion passed unanimously.

8. Discussion and possible action on proposals from TWCA Groundwater Committee – Brian Sledge and Hope Wells, Co-Chairs

Hope gave an update on the work of the GW committee. Five subcommittees met to discuss a variety of issues. Hope thanked the subcommittee chairs and mentioned some non-legislative work with Charles Porter in collaboration with the SW committee. The GW committee operated under the same procedures as it always has: 75% support required to move out of the subcommittee and 90% support to take to full board. This year, however, the GW committee developed a separate category to distinguish between legislation formally initiated by TWCA and legislation that TWCA might more passively support, should it be filed. The committee voted on eight "support only" proposals that met the 90% threshold and did not consider any "initiate" proposals. Hope and Brian then summarized each of the eight following proposals recommended for TWCA support if included in legislation this coming session:

- Requiring additional notice of DFC materials on a website for 30 days
- Allowing TCEQ or the GCD review panel to seek technical assistance from TWDB during the petition for inquiry process
- Allowing reimbursement of review panel members' reasonable expenses during the petition for inquiry process
- Requiring TCEQ's Office of Public Interest Counsel (OPIC) to provide legal counsel to the review panel during the petition for inquiry process
- Clarifying deadlines for updating a management plan and rules after DFC adoption
- Allowing a person with a real property interest in groundwater in the district to petition a GCD for rulemaking
- Clarifying which DFC should be included in a management plan if a DFC is petitioned or determined to be unreasonable
- Requiring notice of an application for a permit or increase in production to an affected landowner

Hope also identified the draft GAM funding paper and committee's recommendation to support legislative funding to update GAMs as well as conceptual support for initiatives related to funding for abandoned or deteriorated wells and regulatory jurisdiction and related funding at the Railroad Commission for P-13 wells. Mark Evans moved, and Mike Turco seconded the motion to approve the proposals from the GW committee as outlined in the board memo and the motion passed unanimously.

9. Staff reports

- (a) Policy and Legislative Affairs Sarah Kirkle gave an update on TWCA committee work, the budget surplus in the legislature and TWCA's plan for supporting general water infrastructure funding, sunset decisions, and Texas Water Day.
- (b) Operations and Membership Adeline Fox gave an update on work with the RMF, new members, the annual report, board questionnaire, Confluence News sponsors, and 2023 conference dates.
- 10. Reports of Committee Chairs, with discussion and possible action:
